## **DOGGIE DAYS**

## DOG WALKING TERMS & CONDITIONS

Dog Walks- £10 per hour/per dog / £17 per hr 2 dog's same household by arrangement

- 1. All dogs will be subject to an initial meet and greet prior to using our walking services. We reserve the right to refuse taking on any dog deemed in their absolute discretion to be, or have the potential to be, dangerous or disruptive.
- 2. The owner is solely responsible for all harm or damage caused by their dog while it is under the care of Doggie Days and agrees to indemnify Doggie Days in full against any liability arising from such harm or damage to third parties.
- **3**. The owner agrees that, in admitting their dog, Doggie Days has relied on the owner's representation that their dog is in good health and has not harmed or shown aggression or threatening behaviour toward any person or any other dog.
- 4. The owner agrees to advise Doggie Days immediately of any unwelcome, aggressive, procreative, or dangerous behaviour of their dog that has potential to cause harm to any other dog or individual
- 5. Doggie Days offer walks where dogs co-mingle in groups and the owner accepts that during normal dog play their dog may sustain injuries. All dog play is carefully monitored to avoid injury, but scratches, punctures, torn ligaments, or other injuries may occur despite the best supervision
- 6. Doggie Days offer walks during the working week Monday-Friday. We do not work bank holidays or weekends unless there is availability to do so and if pre-arranged.
- 7. Doggie Days will only let dogs off the lead once an 'off the lead consent' has been signed and will remain at the discretion Doggie Days.

- 8. The owner is responsible for the full cost of treatment of any injuries or illness that their dog receives while under the care of Doggie Days. The owner authorises Doggie Days to seek such veterinary advice and/or treatment as they deem necessary when unable to contact the owner; however, where possible this will be carried out by the owner and their usual/preferred Vet. The owner agrees to pay all such costs associated.
- 9. Bitches may not attend Doggie Days for walks while in season or pregnant
- 10. The owner agrees to take any necessary measures or precautions to ensure that their dog is continuously free of contagious, infectious, or otherwise communicable diseases. The owner further agrees to notify Doggie Days immediately of any infectious and/or contagious disease or conditions their dog has been exposed to or is affected by. Such diseases and conditions include, but are not limited to: Distemper, Hepatitis, Kennel Cough (Bordetella), Parvovirus, Corona virus, worms, Lyme disease, Fleas, Pregnancy, Infectious Skin Diseases and Intestinal Parasites.
- **11**. The owner consents to their dog being photographed/video during walks to use on social media/advertising
- 12. The owner agrees that although every bit of care will be taken, Doggie Days is not responsible for any lost, stolen, or damaged leads, collars, tags, clothing or any other item left with their dog.
- 13. The owner agrees to ensure their dog has NOT eaten in the hour before any walks to ensure enough time to digest food before any exercise or play. Failure to do so may result in the potentially life-threatening condition Bloat (Gastric Torsion) for which Doggie Days will not be held accountable.
- 14. The owner agrees to provide keys/arrange access to the dog for the agreed walk; failure to do so will result in a cancellation for that day's walk and will be paid in full by the owner.

- 15. The owner agrees that, by signing the key holder waiver this will indemnify Doggie Days in full against any liability arising from loss or damage to the property or its contents, in present and future circumstances.
- 16. In the event of owner cancellation on arrival to collect dog without pre warning, the charge for the walk will still apply for time wasted. If, however, you inform us prior to arrival no charge will be made.
- 17. In the unlikely event Doggie Days needs to cancel walks for any reason, there will be no charge to the customer.
